MEMORANDUM OF UNDERSTANDING

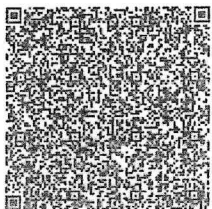
This MOU is made on 18-06-2025, between, Mar Sleeva Medicity Palai, Cherpunkal, Kottayam Dist., PIN: 686584 (A Unit of Pala Diocesan Medical Education Trust a trust incorporated and registered in Kerala) represented by its Managing Director Msgr. Dr. Joseph Kaniyodickal, Herein after referred to as **HOSPITAL** as first party.

AND

Federal Bank Retired Officers Forum (FBROF) having its registered office at FBOA centre, FBOA road Aluva, Kochi, Kerala 683101 the other part engaged and represented by its General Secretary Mr. Paul Mundadan, Herein after referred to as **ASSOCIATION** as second party.

WHEREAS first party **HOSPITAL**, a pioneer in the field of healthcare, provides healthcare services through its hospital, and offers diagnostic, investigations, consultation/opinion, nursing & pharmacological, counselling, procedural & surgical treatment, dietary service and other emergency services.

WHEREAS second party **ASSOCIATION** is desirous of offering its members and their immediate dependents including spouse, children and parents, the facility of undergoing treatments from first party **HOSPITAL**, at discounted rates and the first party **HOSPITAL**, has agreed to offer its expertise and capabilities for the above stated beneficiaries of the second party **ASSOCIATION**.

WHEREAS first party **HOSPITAL** and the second party **ASSOCIATION** after mutual discussions, proposed to enter into this agreement to record the terms and conditions thereof as contained hereinafter in this agreement.

NOW THIS AGREEMENT WITNESSETH

MEDICAL SERVICES

01. REGISTRATION

Every patient is required to register himself/herself in first party **HOSPITAL** for the purposes of identification and maintenance of medical records. The registration offers a unique identification number and the patient can use the same reference number for seeking any services thereafter during the period of this agreement.

02. SERVICES

All the members of Second party **ASSOCIATION** and their immediate dependents shall avail the expert Medical Services of first party **HOSPITAL** for inpatients and out patient's treatment. The first party **HOSPITAL** will provide such medical services on the basis of availability of the same at Hospital.

All members and their immediate dependents including spouse, children and parents of the second party **ASSOCIATION** will be eligible for discounted medical services as mentioned below on production of identity card/authorization letter issued by the second party **ASSOCIATION**. Discounted medical services shall apply only to patients availing cash billing at hospital rates and shall not be clubbed with insurance or any other treatment schemes.

05. BILLING AND PAYMENT

The discounted medical services will be provided only when the second party ASSOCIATION issued identity card/medical card is produced OR the e-mail confirmation from the authorized official of the second party ASSOCIATION.

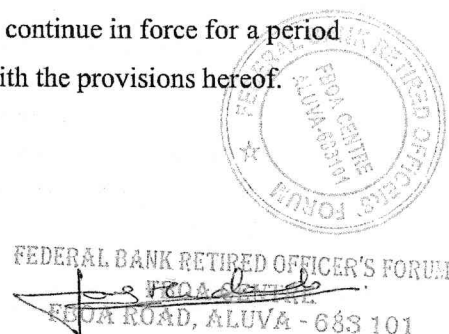

06. TERMS AND TERMINATION

This arrangement will not bind the members to undergo treatment (OP) / in-patient admission (IP)/ and will bind various diagnostic examinations in first party HOSPITAL to avail the discounted rates. This agreement shall come into force from the date hereof "DATE" and shall continue in force for a period of one year from the said date, unless terminated earlier in accordance with the provisions hereof.

By either party upon issue of 30 (thirty) calendar day's prior written notice of termination to the other Party on commencement of the winding up proceedings against the other party or appointment of official receiver or on seeking reorganization or enter into an arrangement under any laws relating to insolvency or industrial sickness by the other party.

The other party committing a material breach of this agreement which breach is not remedied within 30 (thirty) days of service of notice of the breach by the party intending to terminate the agreement.

This agreement may be terminated by the either party without any cause upon issue of 30 (thirty) days prior written notice of termination.

This agreement may be renewed for such further periods and on such terms and conditions as may be mutually agreed between the parties.

07. DISPUTE RESOLUTION

The parties agree to attempt to resolve all disputes arising hereunder, promptly, equitably and in good faith. All disputes, controversies, claims and differences arising out of or in relation to this agreement, or any breach hereof, except those which cannot be settled through correspondence and mutual consultation of the parties hereto, shall be finally settled by arbitration to be conducted in Kottayam district in accordance with the provisions of the Arbitration and Conciliation Act 1996 or any statutory modification(s) or re-enactment thereof for the time being in force.

All arbitration proceedings shall be conducted in english and daily record of such proceedings shall be maintained in english. Notwithstanding anything contained in the agreement, on termination of the agreement this clause will continue to persist until all disputes related to the parties under this agreement have been resolved.

08. CONFIDENTIAL INFORMATION

First party **HOSPITAL** shall use all efforts to keep all the information of the members and their immediate dependents of second party **ASSOCIATION** as confidential and will not disclose or cause or allow the disclosure of such information, unless it is warranted as per law.

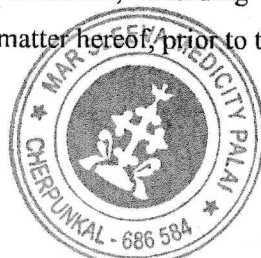
09. AMENDMENTS

No modifications or amendments to this agreement and no waiver of any of the terms or conditions hereof, shall be valid or binding unless made in writing and duly executed by both parties.

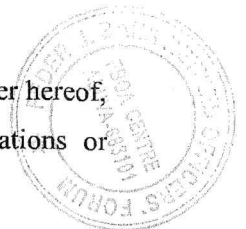
10. ENTIRE UNDERSTANDING

12. ASSIGNMENT

Neither party shall assign and/or transfer any or all of its rights, obligation and/or interests arising or claimed under or by virtue of this agreement to a third party without obtaining the prior written consent of the other party.

13. LAWS AND JURISDICTION

This agreement shall be governed by the laws of India and shall be subject to the exclusive jurisdiction of the courts in Kottayam District.

In case of any disputes arising between the parties in respect of any terms in this MOU, the parties undertake to settle the same by mutual negotiation and in case no such settlement is arrived at after mutual negotiations, the same shall be determined by the Arbitration and Conciliation Act, 1996.

The venue of such arbitration shall be pala and language or arbitration shall be in english. The arbitrator will be appointed by the mutual consent of both the parties, and the decision of arbitrator shall be binding both the parties.

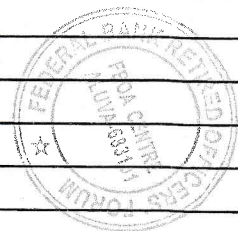
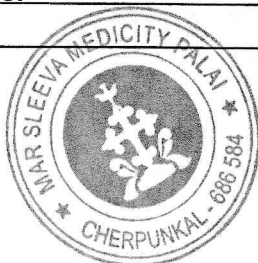

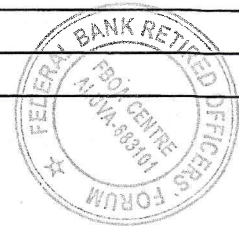
